PART - I

TERMS AND CONDITIONS:

1. The tenderers must get themselves fully acquainted with the area and location of stock yard and godowns vis-à-vis loading/unloading points before submission of Quotations and the rates quoted by them for transportation. Once a tender is submitted, he shall be deemed to have fully acquainted himself, with the area and location vis-à-vis loading, unloading points and he shall not be entitled to any compensation arising out of any discrepancy in size and location of Stock Yard / Godown / loading /unloading points subsequently.
2. In case the rates are quoted in a manner other than that mentioned above, the tenders are liable to be ignored. The tenderers should not incorporate any conditions in the tenders, as conditional tenders will be summarily rejected.
3. Person or Persons attesting the tender shall specify their designation and authority under which they are representing the Firm. In case of partnership firms, the names of all the partners should be disclosed and the tender document shall be signed by all the partners or their duly constituted attorneys having authority to bind all the partners in all matters pertaining to the contract. An attested and notarized copy of the partnership deed should be furnished along with the tender. In the case of a limited company the names of the Directors shall be mentioned and it shall be certified that the person signing the tender is the authorized signatory and is empowered to do so on behalf of the company. A copy of the Memorandum and Articles of Association of the company shall be attached to the tender. In the case of Hindu undivided family the names of the family members should be disclosed and the "KARTHA" who can bind the firm should sign the form and indicate his status below his signature.
4. The person signing the tender form or any documents forming part of the tender on behalf of a firm shall be responsible to produce a proper power of attorney duly executed in his favour indicating his authority specifying that he has authority to bind such other person or the firm as the case may be, in all matters pertaining to the contract. If the person so signing the tender fails to produce the said power of attorney, his quotation will be summarily rejected without prejudice to rights of the Corporation under the law.

The power of attorney should be signed by all the partners in the case of a partnership concern, by the Proprietor in the case of the proprietary concerns and by his signature can bind the company in the case of a Limited Company. In the case of Hindu undivided family the power of attorney should be signed by the KARTHA who by his signature can bind the firm.

5. The rates quoted should be both IN FIGURES AND WORDS inclusive of Loading, weighing, unloading and stacking of the Raw materials at the consignee Destinations anywhere in the State of Karnataka. The raw materials are to be stacked in the manner that will be indicated by the Stores Officer/Officer-in-charge, KSSIDC Ltd.,
6. The rates should be quoted for each Loading and unloading point basis per metric ton as per the slabs detailed in Schedule and shall remain in force during the period of contract. The Diesel/Fuel component of the Freight Rates per MT will be deemed as 25%. The escalation or reduction will be done proportionately for this component only.

The revision of Transportation charges (upward/downward) will be considered once in every six months based on the cumulative increase/decrease in the diesel/fuel prices prevailing on the date of opening tender / quotations.
