Karnataka State Small Industries Development Corporation Limited (KSSIDC Ltd) has proposed to **upgrade Infrastructure of Selected Roads, Drains, Culverts including Designs, Water Supply, Sanitary System, Improvement of Footpaths, Street Light and allied works at Industrial Estate Peenya, 1st Stage.**

5. Tenders must be accompanied by **Earnest Money Deposit (EMD) of Rs. 37.82 Lakh (Rupees Thirty Seven Lakh and Eighty Two Thousand only)**, which shall be paid using the Payment Modes as mentioned below.

10. In case the amount quoted by the tenderer is below the estimated amount put to tender, the **difference amount shall be payable by D.D. drawn in favor of KSSIDC Ltd., to be submitted before issue of work order.**

In the event of the information furnished by Bidder is found to be false during the execution of contract, then KSSIDC is at liberty to cancel the works awarded, also forfeit the performance guarantee furnished, blacklist the firm and recover the losses and execute the balance works at the risk and cost of the contractor.
